Introduction

This publication presents statistical data regarding investigations and recommendations made by the National Commission in Charge of Investigating the Existence of Price Distortions on Imported Goods and its predecessors, between 1981 and 2023¹/.

The information is presented in 38 statistical tables, which show the Commission's actions with regard to petitions filed, initiation of investigations by petition or ex officio, recommendations of provisional and final measures to the President through the Minister of Finance, duration of investigations and the nature of the measures recommended.

It is important to take into consideration that the structure, competence, rules and procedures of the Commission have experienced legal changes and modifications during the period 1981-2023, which should be considered to analyze the statistics. These changes are mentioned in detail in the Methodology Section.

The first Commission of this nature was the Subsidies Commission created after the accession of Chile to the Subsidies Code of the GATT and its promulgation as a Law of the Republic. This first Commission functioned between the end of 1981 and September 1986, plus two sporadic sessions in 1987

The Commission in Charge of Investigating Price Distortions on Imported Goods was created in 1986; it functioned between September of that year and the end of 1989. In 1990 the Commission became a National Commission, the chairmanship changed to the National Economic Prosecutor's Office and its regulations were modified.

This last Commission – which continues functioning until now- has undergone several changes, in particular as a result of the Agreements signed by Chile at the WTO, which became Laws of the Republic.

Since August 1993 the Commission has had the right to recommend antidumping duties and since 1999 it has had the right to recommend safeguard measures according to the Marrakech Agreement. These safeguards replaced the tariff surtaxes established by law 18.525 of 1986. Likewise, in May 1999, the Minimum Customs Values whose recommendation decision corresponded to the Commission were abolished. Finally, in March 2013 a new regulation was enacted (the "Reglamento Antidistorsiones²/"), which replaced two separate regulations³/ that ruled over different kind of investigations.

Methodology

The tables presented below show statistical data from 1981 to 2023, regarding investigations and recommendations made by the National Commission in charge of investigating price distortions on imported goods and its predecessors.

The 38 tables presented provide information on the following tasks of the Commission:

- a) Reception of complaints filed by domestic producers against imports made at distorted prices, or increases of imports in such quantities that cause or threaten to cause serious injury to domestic production. They may refer to one or more products and to one or more origins.
- b) Decisions regarding the initiation of investigations, both for complaints filed and investigations ex officio, and publication of its notice in the Official Gazette.
- c) Recommendation of provisional measures to the President through the Minister of Finance, which currently includes safeguards, countervailing duties and antidumping duties. If a recommendation is accepted, it is legalized by the publication of a Decree of the Minister of Finance in the Official Gazette.
- d) Decisions to terminate investigations and recommendations of final measures to the President through the Minister of Finance, which currently includes safeguards, countervailing duties and antidumping duties. If a recommendation is accepted, the measure is legalized by the publication of a Decree of the Minister of Finance in the Official Gazette.

The statistical tables consider the following variables:

- Number of complaints filed.
- Number of ex officio investigations.
- Total number of investigations initiated.
- Number of investigations withdrawn by the petitioner.
- Number of investigations terminated.
- Total number of investigations with recommendation of provisional and final measures.
- Total number of investigations with application of provisional and final measures.

This information is classified by year, type of product, origin and type of measure.

To elaborate this statistical data the following sources of information, kept by the Technical Secretariat at its archives, were used:

- Minutes of the Commission's sessions.



- Notices of initiation of investigations and other decisions published in the Official Gazette, as initiation, modification and repeal of provisional and final measures.
- Letters from the President of the Commission to the Minister of Finance.

In the analysis of the statistical tables the following considerations should be taken into consideration:

A complaint is considered as an initiated investigation if the Commission has decided to initiate an investigation for one or more products and for one or more origins contained in the complaint.

For the classification by year, it was used the date of the session when the Commission takes notice of the complaint filed and it decides whether to initiate an investigation or not. For initiated ex officio investigations the date considered was the day of the session when the Commission decided to initiate the investigation. In the table titles, the expression "classified by year of initiation decision" refers to the date mentioned above. This date was used due to its availability for all the complaints filed (especially during the eighties), which does not occur for the date of publication of the initiation of investigations in the Official Gazette.

Three sub-periods were established for this report: 1981-1987, 1986-1989 and 1990-2023, which were chosen to reflect main changes experienced by the Commission. The overlap for years 1986 and 1987 is due to the fact that two different commissions were functioning simultaneously during those years (the Subsidies Commission and the second Commission).

Ex officio investigations are recorded since 1990, because that was the year when the legal instruments necessary to carry them out were created. The same is true for recommendation of provisional measures, except in the case of countervailing duties.

Since August 1993, the Commission has had the right to recommend antidumping duties⁴/. Also since May 1999, the Minimum Customs Duties (VAM) were abolished⁵/, while from June 1999 the Commission has the right to recommend safeguard measures⁶/, which replaced the preceding system of tariff surtaxes.

Formal withdrawals of the petitioner are registered since 1990. It is likely that they also occurred before, but were not recorded. In any case, it is a very exceptional situation (four cases during the period 1990-2023).

Likewise, complaints against the international market are registered only since 1990. Previously, the complaints referred to specific origins.

For the statistics of recommendations of final measures were also considered:

- Complaints to the National Customs Service for the adoption of Minimum Customs Duties (VAM), when the Commission didn't have the right to recommend them (right that was granted between June 1986 and May 1999), and
- Recommendations made to the Minister of Finance, between May 1982 and May 1983, to establish specific duties for dairy products, which were considered tariff surtaxes.

Between 1982 and 1987, there were slight differences between the number of investigations that concluded with the recommendation of measures and the number that, according to the records, were actually applied. There are five possible explanations for this difference: special type of recommendations (such as indicated in the previous paragraphs immediately above); rise on the general tariff level to its maximum, which prevented the application of some recommended measures; application of tariff surtaxes to products subject to a complaint, where the Commission decided not to investigate or not to recommend measures; non application by the authority of measures recommended by the Commission; and voids that could exist in the records of that period. Nevertheless, the differences are small.

Since a terminated investigation could end with a recommendation from the Commission to apply more than one measure simultaneously, the total number of measures applied can be higher than the total number of investigations with the application of measures (tables 3 to 6, 15 to 19, 24 to 27 and 32 to 35).

For the classification by sector, the complaints and investigations for wheat flour, sugar and oilseeds were included in the category Agriculture, although strictly they belong to the Food category. The reason for that is because in many legal and regulatory matters these products are related to agricultural sector. Likewise, lighters are registered in the Chemicals category, taking into consideration its essential features, although strictly they should be included in the category of Electric, Mechanic or by Fuel Articles.

The category Electric, Mechanic or by Fuel Articles is the most heterogeneous, and it represents an aggregation of the remaining complaints. However, this category is characterized by the inclusion of high value added products and technological products, such as cars, electrical household appliances, heaters, stoves and ovens, electric meters and water meters.

In tables 20 to 35, there is a detailed breakdown of complaints and investigations by origin. The total and subtotal of each column, for each group of countries correspond to the simple addition of the number of times the origins of each group have been subject to a complaint. These totals are different from the number of complaints because one complaint may include two or more countries (the average is two).

For the classifications by country groups of origin of the imports, the following associations were chosen: North American Free Trade Agreement (NAFTA), Southern Common Market (MERCOSUR), Association of Southeast Asian Nations plus China, Japan and South Korea (ASEAN+3), Other countries, and International Market⁷/. Their composition is shown in the Annex.

Table 36 presents the average number of days spent in the investigations conducted each year. For the average number of days between the date of the session in which the initiation was decided and the date of publication of the initiation in the Official Gazette; and for the average number of days between the date of initiation published in the Official Gazette and the date of the session in which a final decision was taken, it was considered a sample of complaints where such data was available. However, for the average number of days between the date of the session in which the initiation was decided and the date of the session in which a final decision was taken, the data is available for all investigations during the analyzed period. The objective of presenting both results is to allow a deeper analysis in the case of the sample and accuracy in the case of the population. In the case of the average of the population, updating of previous investigations conducted in 1983, 1985 and 1986, and the investigation of Special Agricultural Safeguard from 2014 (into the framework of the Transpacific Strategic Economic Partnership) were not considered because: First, they did not have a formal technical report and second, there was no publication of initiation in the Official Gazette due to the fact that they were analyzed and decisions were adopted in one single session.

In table 37, the average days between the date of the initiation of an investigation published in the Official Gazette and the date of the memorandum recommending provisional measures, is sometimes negative. The reason for this is that for some complaints, the initiation of the investigation and the recommendation of provisional measures were decided in one single session, therefore sometimes the memorandum containing the recommendation of a measure was sent to the Minister of Finance before the publication of the initiation of the investigation.
